**DECLARATION OF A STATE OF WAR
ADDRESS OF THE
PRESIDENT OF THE UNITED STATES**

**DELIVERED BEFORE A JOINT SESSION OF
THE TWO HOUSES OF THE CONGRESS ON
APRIL 1, 2009**

REQUESTING THAT

**THE CONGRESS DECLARES THAT A STATE OF
WAR HAS EXISTED SINCE JANUARY 20, 2001,
BETWEEN THE EXALTED POLITICIANS OF THE
FEDERAL GOVERNMENT OF THE UNITED
STATES AND THE MIDDLE-CLASS AMERICAN
CITIZENS OF THE UNITED STATES.**

**The SPEAKER. The Clerk will read the joint resolution.
The Clerk read as follows:**

"Declaring that a state of war exists between the Middle-Class Citizens of the United States and the Exalted Politicians of the Federal Government of the United States and making provisions to prosecute the same.

"Whereas the Middle-Class Citizens of the United States have unreasonably demanded that the Exalted Politicians of the United States perform their elected duties and that they have committed repeated acts of disrespect, sarcasm and satire against the Exalted Politicians of the Government of the United States of America:

"Therefore be it

"Resolved, etc., That the state of war between the Exalted Politicians of the Federal Government of the United States and the Middle-Class Citizens of the United States is hereby formally declared; and that the President is hereby, authorized and directed to employ the entire naval and military forces of the United States and the resources of the Government including law enforcement personnel and apparatus to carry on war against the Middle-Class Citizens of the United States; and to bring the conflict to a successful termination, all of the resources of the Exalted Politicians of the Federal Government are hereby pledged by the Congress of the United States."
